(or any Google brand), Amazon, Inc., Twitch.tv, EA Sports, the National Hockey League ("NHL"), the United States Football League ("USFL"), the National Basketball Association ("NBA"), the National Football League ("NFL") or their subsidiaries or affiliates.

- 1. PROMOTION TIMING:** The Promotion begins on Friday, April 22, 2022 at 12:01 AM Eastern Daylight Time ("EDT") and ends approximately on Thursday, August 4, 2022 at 11:59:59 PM EDT, after the completion of the Pro Football Hall of Fame football game ("Promotion Period"). Sponsor's computer is the official clock for the Promotion.
- 2. ELIGIBILITY:** The Promotion is offered only to individuals who are legal residents of the United States, at least twenty-one (21) years of age of the individuals on the date of entry (each, an "Entrant"). Unless otherwise specified herein, employees, officers, directors, representatives, and agents of Sponsor and Media Sponsor, and each of Sponsor's and Media Sponsor's respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Promotion Entities") and each of their immediate family members (e.g., spouse, domestic partner, parent, child, sibling, and the respective spouses and immediate family members of each, regardless of where each resides) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Sponsor reserves the right to update these OFFICIAL RULES – APRIL 21, 2022, and shall reflect the date of the latest update in the Notices section (below). All entries become the sole and exclusive property of Sponsor and receipt of entries

will not be acknowledged or returned. For purposes of the Promotion, an individual Entrant's residential address and e-mail address will be the residential address and e-mail address submitted by the individual Entrant at the time of entry. Each Entrant may only be associated with a single e-mail address.

NOTE: During the Promotion, Sponsor is deploying its patented Super Squares® application and platform within a unique early-stage environment synchronized to broadcasting of sporting events ("Application"). Sponsor invites participants to assist in the ongoing development and maturation of Sponsor's platform, while also competing with other participants, to win prizes. DUE TO THE NATURE OF SPONSOR'S APPLICATION AND PLATFORM, PARTICIPANTS ARE ADVISED, ACKNOWLEDGE AND ACCEPT THAT THERE MAY BE LIMITATIONS TO THE NUMBER OF PARTICIPANTS ENABLED TO PLAY, AND THAT THERE IS A POTENTIAL THAT SOME FUNCTIONS OF GAME PLAY AND OF THE APPLICATION MAY BE IMPAIRED, MODIFIED AND ALTERED DURING THE EVENT. SPONSOR MAKES NO WARRANTIES, EXPRESS OR IMPLIED, REGARDING THE SUFFICIENCY, ACCURACY AND/OR COMPLETENESS OF THE VERSIONS OF THE APPLICATION DURING THE PROMOTION PERIOD FOR ANY PURPOSE, INCLUDING NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR ANY PURPOSE. FURTHER, NO ASSURANCES ARE EXPRESSED OR IMPLIED THAT THE APPLICATION, OR ANY PARTICIPANTS' DEVICE OR WIRELESS SERVICE PROVIDER, WILL ENABLE OR SUPPORT GAME PLAY OR THE APPLICATION FOR THE DURATION OF ANY SPORTING EVENT, GAME SHOW, OR FOR THE FULL LENGTH OF THE PROMOTION PERIOD.

- 3. HOW TO ENTER AND PARTICIPATE IN THE PROMOTION:** Before and during the Promotion Period, an eligible Entrant may download the Application from the Entrant's smart phone/mobile device via the Apple® App Store or Google® Play Store, and follow the links and instructions to register and create an account ("Account") on the Application by providing all of the information requested by Sponsor including, but not limited to: complete first and last name, city and state of residence, zip code, mobile phone number, date of birth, unique and valid e-mail address, a created password, and agreement to be bound by these OFFICIAL RULES – APRIL 21, 2022. Limit: An Entrant may only create one (1) Account, whether before or during the Promotion Period, which Account is associated with the Entrant's smart phone/mobile device, residential address and unique and valid e-mail address. The unique and valid e-mail address provided during registration shall be deemed the eligible Entrant's "Official Email Address."

During the Promotion Period, there will be one or a series of mobile game shows (each a "Game Show") that will be conducted and synchronized with a posted live sporting event played by teams and players associated with the National Hockey League ("NHL®"), National Basketball Association ("NBA®"), USFL, and National Football League ("NFL®") (each a "Live Game"). Each Entrant must check local listings for scheduled start times and dates, as well as details that may be provided within the Application. Sponsor has no control over, and is not responsible for, any broadcast interruptions, errors or delays, or any programming decisions made by any television or radio service provider affecting the broadcast of the Live Game. In the event a specified Live Game is not aired on a designated date or is delayed by more than sixty (60) minutes, cancelled, suspended or rescheduled, or if the Game Show is negatively impacted as a result of the performance of the Application or Sponsor's application host or related applications, Sponsor reserves the right to end the Game Show without selecting winning entries for that Game Show. In the event of multiple instances of delays, suspensions or rescheduling of Live Games, or delays in or suspension of the respective sports league's Season, Sponsor reserves the right to suspend, extend or end the Promotion, at its sole discretion.

The Promotion Period will span from Friday, April 22, 2022 at 12:01 AM Eastern Daylight Time ("EDT") through Thursday August 4, 2022 at 11:59:59 PM EDT, in weekly cycles spanning generally

from Monday mornings to Sunday evenings. Sponsor will from time to time announce via the Application, the number of Game Shows to be conducted, along with identifying the Live Games to be supported by the Application. **Entrants will be limited, where applicable, to selecting and playing only one (1) Game Show per sport, per unique hourlong start time (each a “Live Game Slot”).** While Sponsor retains the right to limit the number of Game Shows Sponsor conducts each week, Sponsor intends to host one (1) or two (2) Game Show(s) featuring matchups from the USFL or NFL, as well as, or alternatively, one (1) or two (2) Game Show(s) featuring matchups from the NHL and NBA playoffs when available, generally coinciding with the following Live Game schedule:

- Sunday, April 24, 2022
- Sunday, May 22, 2022
- Sunday, June 5, 2022
- Sunday, June 19, 2022
- Thursday, August 4, 2022
- Optional Sunday Flex Date

Sponsor reserves the right to combine multiple Game Shows and Live Game Slots within a Game Day, forming a single daily Game Show Prize Pool (as further described below). During the Promotion Period, Sponsor reserves the right to host up to three (3) “Exhibition Game Shows” (one or more Game Shows introducing new sports or game show features, with reduced prize levels). Exhibition Game Show scores and prizes will not be combined with other Game Shows and Game Show Prize pools.

Throughout the Promotion Period, Sponsor shall identify or confirm via the Application, and via Sponsor’s website located at www.SuperSquares.com, the Live Games and Live Game Slots proposed to be supported by Sponsor with a Game Show. Live Games and Live Game Slots are subject to change.

PRE-GAME ACTIVITIES:

During each Game Show there will be one (1) Pre-Game Break, which will be available for game play before and briefly at the start of the Live Game. Entrants may receive a notification before the Pre-Game Break based upon the capabilities and settings of an Entrant’s smart phone/mobile device. The Pre-Game Break “Window” during which an Entrant may participate is as follows:

****Notifications may occur days in advance of the Game Show. Entrant’s smart phone/mobile device that have turned off notifications, or that is incapable of receiving notifications, may not display a notification. Entrants may still participate without having received a notification.***

Before the Pre-Game Break Window closes, an Entrant seeking to post points and participate, and receive a Super Square, must check-in to the Game Show via the Application.

Upon checking in to Pre-Game Break of the Game Show, the Entrant will be assigned to a game group (“Game Group”). There will be no more than twenty-five (25) Entrants in each Game Group, with the exception of Entrants who join the Game Show after the start of the Live Game, who may be placed into a Game Group in excess of twenty-five (25) Entrants.

During the Pre-Game Break, in addition to other activities described below, Entrants will be asked three

(3) Live Game prediction questions (“Predicter Questions”) that must be completed before or shortly after the official start of the Live Game, in order to qualify for Predictor Points at the end of the Live Game. At the conclusion of the Live Game, Entrants who checked-in and timely answered the Predictor Questions will earn up to sixteen (16) points per correct answer.

Each entrant will also be randomly assigned a new Super Square (“Super Square”). The same Super Square will not be assigned to more than one (1) entrant in the same twenty-five (25) entrant Game Group. Each randomly assigned Super Square will contain four (4) sets of statistic combinations (e.g. “3,7”) which will correspond to the last digit of the visitor and home teams’ score (for football and basketball), or Shots on Goal (SOG) for hockey Live Games. Each entrant will receive a total of four (4) Super Squares during each Game Show, with a new Super Square assigned at the start of each subsequent quarter or period, each scored over the course of the Game Show. For hockey Game Shows, the fourth and final Super Square shall be assigned at the conclusion of the 3rd Period, and in the event there is no Overtime Period (and the match concludes after the end of the 3rd Period), the fourth Super Square, like the immediately preceding third Super Square, shall be scored based upon the SOG statistic at the conclusion of the 3rd Period (i.e. end of the Live Game). For football or basketball Live Games, the final Super Square shall be scored based on the final Live Game score, including any overtime periods.

For NCAA basketball Live Games, as games are divided into halves and not quarters, the 2nd and 4th Super Squares shall be randomly assigned at the first stoppage of play with less than 12:00 game time minutes remaining in the half (“Media Time Out.”), with the final Super Square score being based upon the final score, including any overtime periods.

During the Pre-Game Break, Entrants will participate in activities to earn points as outlined below:

- **Rate Commercials:** During the Pre-Game Break, Entrants will be served Mobile TV Commercials within the Application. Following the completion of a Mobile TV Commercial, Entrants will be permitted to replay the Mobile TV Commercial one additional time. Each Entrant will have up to seven (7) seconds within which to react to the Mobile TV Commercial by selecting a star rating of 1, 2, or 3 stars, reflecting the Entrant’s general sentiment about the Mobile TV Commercial. A 1-star rating reflecting a less favorable sentiment, a 2-star rating reflecting an average sentiment, and a 3-star rating reflecting a more favorable sentiment. Selecting ANY of the three separate star ratings within the seven second window will entitle the Entrant to one (1) point. There will be no difference in points earned regardless of which one of the three separate star ratings is selected. There will be a total of two (2) opportunities to rate Mobile TV Commercials. **There is a possible total of two (2) points per Game Show for rating Mobile TV commercials. Entrants must check in during the Pre-Game Break Window to be eligible for these points.**
- **Answer Quiz Questions:** During the Pre-Game Break, Entrants may be asked two (2) multiple choice quiz questions based on the content of the two (2) Mobile TV Commercials served in the Application. One or both of the two quiz questions may instead be presented as an offer or survey question. Entrants will have up to twenty (20) seconds to complete each quiz question. Once an Entrant answers a quiz question, the Entrant will not be able to change the Entrant’s answer. An Entrant will earn three (3) points for each quiz question the Entrant answers correctly, or, in the instance of offer or survey questions, for selecting a response reflecting the Entrant’s choice or opinion. Entrants are NOT required to reply in the affirmative to any offer or survey question to earn points. There will be a total of two (2) quiz questions per Game Show. **There is a possible total of six (6) points per Game Show for quiz-related questions. Entrants must Check In during the Pre-Game Break Window to be eligible for these points.**
- **Super Squares Score Statistics:** During the course of the Event, an entrant can compare Super

Square numeric combinations to a designated Stat for the type of sport (i.e. the score for football and basketball, and the SOG for hockey). Each Super Square will have four (4) squares, each containing a numeric combination. An entrant will earn three (3) points for each "Partial Square" combination (where one (1) of the two (2) combinations matches the last digit of the Stat of the corresponding visiting or home team) at the end of the respective increment (i.e. quarter, period, etc.) An entrant will earn five (5) points for a "Perfect Square" combination (where the combinations match the last digit of the Stat of BOTH the visiting and home team). By way of example for hockey, a square combination of 3,7 would earn three (3) points and be designated a Partial Square, in the event the visiting team's Stat (SOG) ends in a "3" (i.e. 3, 13, 23, etc.) or if the home team's SOG ends in a "7" (i.e. 7, 17, 27, etc.). **Therefore, a Super Square that contains two Partial squares is designated a Partial Super Square and will yield 6 Game Show points.**

If the square combination matches BOTH teams (i.e. the visitor team has 23 SOG's and the hometeam has 17 SOG's, with an entrant claiming the 3,7 combination) this would be designated a "Perfect Square" combination and the entrant would receive five (5) points. Entrants who receive a Perfect Square combination will also be awarded three (3) points for each of two (2) Partial Square combinations contained within the entire Super Square. **Therefore, a Super Square that contains a Perfect square and two Partial squares is designated a Perfect Super Square and will yield 11 (eleven) Game Show points.** There are a possible total of forty-four (44) Super Square-related Game Show points.

NOTE re: Hockey Live Games: Shots on Goal (SOG) are subjective in nature. Sponsor relies upon statistics provided by SportRadar, a world leader in live sport statistics. On occasion, SOG statistics may be reversed or adjusted later or even after the event, by our statistics provider, Live Game officials, or NHL league officials. Sponsor will allow up to five (5) minutes of time to transpire at the conclusion of a Period, before finalizing the SOG statistic that will be used for scoring a Super Square, and the final result for any Predictor Questions that include the SOG statistic (per below). **Sponsor will NOT alter the Super Square combinations or Final Predictor Results once a Super Square score has been finalized and posted in the app.**

- **Predictor Questions:** Entrants who check-in and complete the Pre-Game Break prior to, or shortly after, the start of the Live Game are eligible to earn up to sixteen (16) points from each of the three (3) Predictor Questions. Predictor Question point values are based on an Entrant's percentile rank (utilizing a proprietary formula created by Sponsor) when compared to the final result of the predicted event. When ranking predictions that require a selection of one (1) of two (2) teams, as well as a number of points, shots or minutes and seconds, all predictions that select the wrong team will score zero (0) Predictor Question points, as only predictions that select the correct team are eligible to be ranked and to receive points. **The maximum number of Predictor Question points that can be earned is 48.**

IN-GAME ACTIVITIES:

After an Entrant has completed the Pre-Game Break, but prior to the completion of the Live Game, Sponsor may provide Entrants with the opportunity to earn additional Game Show points, as outlined below:

In-Game Reactive Experiences ("RXP's"): Entrants may be provided with an opportunity to "React and Rate" up to eight (8) additional Mobile TV Commercials within the Application. Entrants will be presented with a "React" button within the Application display, and the React Button shall designate in its upper right corner, the number of In-Game RXP's available during the Game Show. When activated by Sponsor, the Entrant may press the React button and be served a Mobile TV Commercial. As with the Pre-Game Break activities described above, following the completion of the Mobile TV Commercial, the Entrant will be able to replay the Mobile TV Commercial one additional time. The Entrant will have up to seven (7) seconds within which to react to the commercial by selecting a star rating of 1, 2, or 3 stars, and selecting ANY of the three separate star ratings within the seven second window will entitle the Entrant to one (1) point.

Entrants will then be asked one (1) multiple choice quiz question, which may be in the form of an offer or a survey question. Entrants will have up to twenty (20) seconds to complete each quiz question. Once an Entrant answers a quiz question, the Entrant will not be able to change the Entrant's answer. An Entrant will earn three (3) points for each quiz question the Entrant answers correctly, or, in the instance of offer or survey questions, for selecting a response reflecting the Entrant's choice or opinion. Entrants are NOT

required to reply in the affirmative to any offer or survey question to earn points.

The In-Game RXP Mobile TV Commercials and quiz questions, offers or surveys may be randomly served to Entrants such that some Entrants may receive different In-Game RXP Mobile TV Commercials and quiz questions, offer or surveys than other Entrants. For Game Shows that offer In-Game RXP's, once the Entrant has been presented with the number of designated opportunities to "React and Rate" to receive additional In-Game RXP Game Show points, and prior to the commencement of the next quarter of play in the Live Game, regardless of the total of points earned, the "React" button will be deactivated, and no other In-Game RXP's (and related points) will be made available.

There may be a possible total of up to eight (8) points per Game Show for rating In-Game RXP Mobile TV Commercials, and a possible total of up to twenty-four (24) points per Game Show for In-Game RXP quiz questions. The maximum total of Points that can be earned from In-Game RXP's will be up to thirty-two (32) points.

The Game Show points earned from In-Game RXP's will be added to the points earned from Pre-Game activities, Predictor Questions, and Partial and Perfect Super Squares, to arrive at the Final Game Show Score, also referred to as their FINAL SCORE. NOTE: Players of Classic and Watch Party Game Shows are eligible for most prizes described below based on their FINAL SCORE. Players of Watch Party Game Shows do NOT have an advantage over players of Classic Game Shows for the identical Live Game, when competing for prizes tied to a FINAL SCORE.

If an Entrant closes the Application at any time during the Pre-Game Break or engages in other activities that could impact an Entrant's smart phone's/mobile device's use of resources and operations, the Application may expel the Entrant from the Pre-Game Break and may not award any or all points from the affected Pre-Game Break. Entrants are strongly advised to avoid opening or utilizing other smart phone/mobile applications during a Pre-Game Break. For Entrants using smart phones/mobile devices with limited memory, clearing the smart phone's/mobile device's caches (or Media Cache within the Application's "Settings" tab) before the Pre-Game Break may increase an Entrant's smart phone's/mobile device's ability to complete a Pre-Game Break.

Entrants may join the Game Show after the start of the Live Game and may be eligible for Game Show points. However, to maximize Game Show points, Entrants must check in prior to eight (8) real-time minutes to participate in a Game Show.

Entrants may submit no more than one (1) FINAL SCORE for a Game Show.

WATCH PARTY GAME SHOWS:

During some Game Shows, Entrants may be alerted via the Application, and Sponsor's livestreaming hosts at www.SuperSquares.TV, about the time-sensitive ability to join a Watch Party Game, where there will be availability of "BONUS BREAK" quizzes and polls, as well as "POWERPICK™" in-game predictions and possible "PREDICTER SQUARES™" opportunities. **Watch Party Game Shows may be joined by tapping the "Join Watch Party" button in the lower left hand corner of the Game Show display once the event has started. Players who elect to join the Watch Party Game are still eligible to win Game Group and other prizes available to non-Watch Party ("Classic") Entrants, based upon each Entrant's FINAL SCORE.**

Watch Party Game Shows award a limited number of additional prizes, based upon the Watch Party Scores of ALL Watch Party participants. All participants in a Watch Party Game Show will have their Watch Party Scores displayed within a single Watch Party Leaderboard. **NOTE: Unlike Classic Game Show Entrants, Watch Party participants should be prepared to watch the entire Live Game, as well as the livestream event at www.SuperSquares.tv, in real-time, to increase the possibility of winning Watch Party Prize(s).**

Players who elect to join a Party Game Show will obtain, upon its completion, both a **FINAL SCORE** (comprising the points earned and collected from Pre-Game and In-Game RXP's, Predictor Questions, and Partial and Perfect Super Squares), as well as a **Watch Party Score**, comprising the total of the FINAL SCORE plus or minus additional Watch Party points earned or lost from a Bonus Break, a POWERPICK™, and Predictor Square switch (described below). **The FINAL SCORE will be utilized to determine winners of all daily Game Group and weekly prizes and tournament prizes, if and when applicable. The Watch Party Score shall solely be**

utilized to determine winners of Watch Party Prize(s), unless otherwise stated, below.

Watch Party events will, at Sponsor's sole discretion, provide Entrants with the opportunity to earn Watch Party points as follows, which will be added to the FINAL SCORE, to comprise the Watch Party Score:

BONUS BREAK: At any time prior to the end of the Live Game, including during the halftime period, Entrants may be provided with a limited one-to-seven-minute opportunity to participate in one or more Bonus Breaks, each comprising a brief introductory or explanatory video followed by two Bonus Break quiz questions, offers or survey questions. To participate in a Bonus Break, an Entrant may be required to have the Application open and in view during the timeframe during which the Bonus Break is "active." Sponsor may, but is not required to, notify Entrants via push notification or other means when a Bonus Break is available for participation.

Entrant will be notified when a Bonus Break is available via the "React" button flashing or otherwise indicating availability via a blue glow or strobe, accompanied with the word, "Bonus." To participate, the Entrant must press the "React/Bonus" button, to then be served a brief video or image followed by two Bonus Break quiz questions, offers or surveys. The Bonus Break quiz questions, offers or surveys may relate to topics concerning the Live Game, the preceding in-app video or image, on-air TV commercials, activities taking place during the SuperSquares.TV livestream, or any other topic approved by Sponsor. Entrants will be afforded up to twenty (20) seconds to complete each Bonus Break quiz question, offer or survey. Once an Entrant answers a Bonus Break quiz question, the Entrant will not be able to change the answer. An Entrant will earn three (3) points for each correctly answered Bonus Break quiz question, or, in the instance of offer or survey questions, for selecting a response reflecting the Entrant's choice or opinion. **Up to six (6) BonusBreak points may be earned per Bonus Break.**

Once an Entrant has participated in an individual Bonus Break, or upon the expiration of the availability to participate in the Bonus Break, the "React/Bonus" button will be deactivated and return to its prior state.

There may be a possible total of up to eight (8) Bonus Breaks per Watch Party Game Show, and a possible total forty-eight (48) Bonus Break points that can be earned per Watch Party Game Show.

POWERPICK™: At any time prior to the end of the Live Game, Entrants may be provided with a limited thirty second to seven-minute opportunity to participate in one or more POWERPICK™ points-wagering opportunities. Entrants who choose to participate may wager from zero (0) to three (3) POWERPICK™ points prior to making a selection as follows:

Pick2 Quiz – Choose from 1 of 2 choices, for a 2X award if Correct.

Example: *Will the Home team score during the remaining 5 minutes of the game?*
Yes or No

Pick4 Quiz – Choose from 1 of 4 choices, for a 3X award if Correct.

Example: *Which team(s) will score 2 or more goals this Period?*
Home team or Away team or Both teams or Neither team

To participate in a POWERPICK™, an Entrant may be required to have the Application open and in view during the timeframe during which the opportunity is "active." Sponsor may, but is not required, to notify Entrants via push notification or other means when a POWERPICK™ is available for participation.

Entrant will be notified via the "React" button flashing or otherwise indicating availability via a green glow or strobe, accompanied with the alternate words, "Pick2" or "Pick4." To participate, the Entrant must press the "React/Pick" button to be served the POWERPICK™ quiz question, make a points wager, and select a choice to submit the Pick, initiated within the permitted time window announced via the TV broadcast, a push notification, or both. The POWERPICK™ quiz question may relate to upcoming events within the broadcast or other live Live Game(s), or other content deemed suitable for real-time prediction by Sponsor or Media Sponsor, in their sole discretion.

Entrants will be afforded up to twenty (20) seconds to select a points wager and submit Entrant's choice. In the event a predictive event resolves prior to the conclusion of the allotted time window and 20 second

answer period, all related POWERPICK™ predictions will be voided.

Entrants must have sufficient earned Game Show points to post a POWERPICK™ wager. Entrants may wager zero (0) points in order to be notified of the outcome of the POWERPICK™. Points wagered will be deducted from an Entrant's Watch Party score if answered incorrectly, and upon correctly predicting, will be credited to the Entrant's Watch Party score by a factor of 2 or 3, for Pick2 and Pick4 Quizzes, respectively.

For example, an Entrant with a Watch Party score of 20 points wagers 2 points during a Pick2. If correct, the Entrant will receive an additional 4 Watch Party points, for a total of 24 Watch Party points; if incorrect, the Entrant's score will reflect a deduction of 2 points, reducing the Watch Party score to 18. Under this same example, a 2-point wager for a Pick4 would result in a Watch Party score of $20 + 6 = 26$ points if correctly predicted, and a deduction to 18 points if incorrect.

Once an Entrant has participated in an individual POWERPICK™, or upon the expiration of the availability to participate in the POWERPICK™, the "React/Pick" button will be deactivated and return to its prior state. **Up to eight (8) POWERPICK™ quiz questions may be presented during a Watch Party Game Show.**

PREDICTER SQUARES™: Sponsor reserves the right to enable the Predictor Squares™ feature during Watch Party Game Shows which, when enabled, allows Entrants, once per quarter or period, to switch their Super Square for an alternate Super Square. The "New" Super Square will be selected from all adjacent Super Squares, and when confirmed, will be designated on the game board in purple. The general strategy enabled by the Predictor Squares™ feature is to allow an Entrant to "trade up" from a Super Square that is predicted to earn fewer or no points at the end of the quarter or period, for a New Super Square that will earn points for being a Partial or Perfect Super Square. Entrants may elect to switch away from a Partial Super Square to an adjacent Super Square predicted to be Perfect by the end of the quarter or period.

There is risk associated with switching Super Squares. The original Super Square will remain in the Entrant's possession for the duration of the quarter or period, for the purposes of generating their Final Game Show score. However, the Watch Party score will be impacted when an Entrant switches their Super Square for a New Super Square, as follows:

- 1) **Switch Fee** – Entrants who switch Super Squares within the first two minutes of the quarter or period (based on the official time remaining for the sporting event), will have **one (1) Watch Party point** deducted from their Watch Party Score. In the event a hockey game ends after three (3) periods, there **will not** be an opportunity for Entrants to switch from their fourth and final Super Square to an alternate Super Square.

NOTE: During the Promotion Period, Sponsor reserves the right to develop and implement additional in-game activities that may award or deduct Watch Party Points based on the actions taken by Entrants.

Super Squares® Game Shows are skill contests designed to increase consumer awareness of, and interest in, professional sports, advertisers and brands. In order to win Game Show prizes, Sponsor reserves the right to require Entrants score at least 25 Game Show points from In-Game RXP quiz and Predictor Questions for Classic Game Shows, and at least 35 points from In-Game RXP quiz and Predictor Questions, Bonus Breaks and POWERPICKS™ for Watch Party Game Shows.

The Super Squares® Application and Game Shows may not be used for, or in connection with, any form of gambling for monetary prizes or other monetary compensation.

Sponsor will rely upon statistics and the Live Game clock time provided to Sponsor by a statistical data provider, for the purpose of tracking statistics, including time, scores, shots and starting and ending Pre-Game Breaks and Pre-Game Break Windows. Participants acknowledge that statistics are subject to change during or even after the Live Game. Pre-Game Break notifications, Live Game scores, statistics and Predictor Question statistical results, once integrated within the Application and the live Game Show, will not be updated to reflect any statistics changes or corrections that may occur after the completion of a Pre-Game Break or the Game Show. Due to delays and buffers within Live Game broadcasts and streams, the statistics and results that occur during the broadcast may be reflected within the Application on a periodic basis and may differ from the real time statistics. Quiz answers deemed correct or incorrect by Sponsor shall remain final, even in the event of statistics changes or corrections or an error or omission by Sponsor, including but not limited to, clerical, typographical or technical errors or omissions.

IMPORTANT: Message and data rates may apply. Please consult your wireless-service provider regarding its message and data pricing plans.

4. **WINNER DETERMINATION AND PRIZES:** After the conclusion of each Live Game, Entrants will obtain a FINAL SCORE, visible from within the Application. Entrants who receive the highest number of points in the categories outlined below, and/or who score highest in their respective Game Group, will qualify to be deemed a potential winner (“Potential Winner”). A Potential Winner as defined herein may be designated a winner (“Winner”) once Sponsor verifies the Potential Winner’s eligibility and compliance with these OFFICIAL RULES – APRIL 21, 2022, at its sole and absolute discretion.

Sponsor reserves the right to increase the number and/or value of prize values in excess of the stated base quantities and values found within these OFFICIAL RULES – APRIL 21, 2022, as well as the right to add additional award categories. Increases in the quantity and/or value of prizes and award categories will be clearly displayed within the Application.

The following comprises a list of base prize quantities and values to be awarded:

In the event more than one player qualifies for the final Top Game Group Winner Prize(s), a random drawing among all qualified and tied Top Game Group Winners will be conducted by Sponsor in order to award the prize(s). In the event there are not at least as many Game Groups created during a Game Show or Game Show Slot as the number of Top Game Group Winner Prizes to be awarded, the number of Top Game Group Winner Prizes to be awarded shall equal the total number of Game Groups created.

The maximum ARV of total Top Game Group Winner Prizes to be awarded during the Promotion Period (including from Exhibition Game Shows) is \$3,300.00.

(48) **Buddy Referral Prizes:** As an incentive for fully qualified and registered Entrants to invite others to register and participate, such full qualified and registered Entrants may refer qualified participants **who have not yet registered**, to participate, by supplying the unregistered participant with the registered Entrant's official e-mail address or screen name used within the Application. In the event the unregistered participant subsequently, completely and correctly enters the referring Entrant's Official Email Address or screen name during the initial registration process, or when not provided during the initial registration, within forty-eight (48) hours thereafter (and no other time in the future), in the noted field of the registration form, the fully qualified and referring Entrant shall be deemed to be the "Buddy" of the newly-registered Entrant ("Friend.") **Buddy referrals that occurred prior to the Promotion Period remain eligible for awards during this Promotion Period.**

For the duration of the Promotion Period, the Buddy (where applicable) shall receive a matching and identical prize award (a "Buddy Referral Prize") when a Friend is officially awarded one of the following prize types:

- i. **Perfect Game Jackpot Prize**
- ii. **Top Game Group Winner Prize**

Two Highest Final Watch Party Scores: \$50 Game Show sponsor Digital Gift Code

In the event more than one (1) Potential Winner earns the same Final Watch Party Scores, the Potential Winner with the highest Predictor Question points will be declared the Winner. In the event more than one player qualifies for the final Watch Party Prize(s), a random drawing among all qualified and tied Watch Party Winners will be conducted by Sponsor in order to award the prize(s). **The identity of the merchant or Sponsor issuing the digital gift code will be confirmed during the first fifteen (15) minutes of the livestream at www.SuperSquares.TV. Sponsor reserves the right to fulfill any Sponsor-designated Gift Code to be awarded with a prize of equivalent or greater value from the merchant or sponsor of Sponsor's choice.**

The maximum ARV of total Watch Party Prizes to be awarded during the Promotion Period is \$400.

D. SkyBox, VIP SkyBox, and Optional SkyBox Contests: The Application enables Entrants to create for each Game Show, a dynamic by-invitation leaderboard (“SkyBox”) consisting of a ranked list of current Game Show scores from multiple invited users participating within different Game Groups. Creators of a SkyBox will name the SkyBox and will create a SkyBox unique “Passcode” to be shared with other Entrants. SkyBoxes can be “joined” by Entrants entering the unique Passcode within the Application. The Entrants and scores displayed within a SkyBox may be used for entertainment purposes by Entrants and Media Partners. **Entrants may create and/or join up to two (2) SkyBoxes per Game Show.**

“VIP SkyBoxes” may be created and utilized by Sponsor, Media Sponsor, Brand Sponsors, or Media Partners approved by Sponsor, and may display banner images of Brand Sponsors, Media Partner or Media Partner’s brand sponsors, and an associated Twitter® feed. VIP SkyBoxes may, at times, be utilized to present contests and award related prizes to participants (“VIP SkyBox Contests”), based on the results and rankings of Entrants whose Game Show or Watch Party scores are presented within the VIP SkyBox.

- b. **VIP SkyBox Contest Winners and Prizes.** Following an Official VIP SkyBox Contest Announcement, the winning VIP SkyBox Entrant(s) shall be posted and accessible via the banner and link located at the bottom of the VIP SkyBox display within the Application.
- c. **SuperSquares.TV VIP SkyBox Prize.** The VIP SkyBox associated with Sponsor’s SuperSquares.TV streaming channel(s) may award a Top Score Prize to one or more of the VIP SkyBox Entrants with the highest Final Game Show score(s) or Final Watch Party Score. The Passcode to each VIP SkyBox, method by which a winner shall be selected and prizes to be awarded shall be announced “on-stream” during the first quarter of play in the Live Game. In the event more than one (1) Potential Winner earns the same winning score, the Potential Winner with the highest Predictor Question points will be declared the Potential Winner. **Entrants must join the SkyBox prior to the completion of the Live Game’s 1st Quarter to be eligible for inclusion in VIP SkyBox Contests.**

- d. **Winner Notification.** Entrants who participate in a VIP SkyBox Contest authorize Sponsor to provide the Media Partner or Brand Sponsor with the Screen Name, first and last name, e-mail address, and telephone number associated with the Entrants earning the ten (10) highest scores at the conclusion of the Game Show or Game Week. **Entrants acknowledge that SkyBoxes may not be used by Entrants or Media Partners in any capacity for gambling purposes.**

F. - 5. HOW TO CLAIM A PRIZE:** Each Potential Winner will be notified via e-mail by Sponsor or Sponsor's authorized designee at the Potential Winner's Official Email Address. If a Potential Winner is disqualified, found to be ineligible or not in compliance with these OFFICIAL RULES – APRIL 21, 2022, or declines to accept the prize, the prize may be forfeited, and in the Sponsor's sole discretion, the forfeited prize may not be awarded, or may be awarded to an alternate winner, selected by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be awarded.

such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Promotion; (vii) any injury or damage, whether personal or property, to Entrants or to any person's computer related to or resulting from participating in the Promotion and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the OFFICIAL RULES – APRIL 21, 2022.
